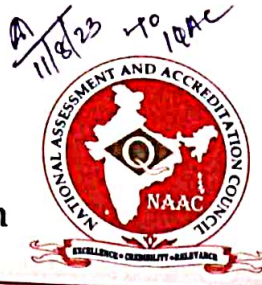

Greetings from NAAC,


